1) Welcoming new members and Secretary General

- The WG Chair extends a warm welcome to OnTurtle as a new member of the Working Group on Payment.



- The new FCE Secretary General, Aurélie Decker Peigneur, is also introduced.

2) Competition compliance reminder

FCE Secretary General reminded all participants to comply with competition law and circulated the Do's and Don'ts.

3) Status of PSR/PSD3 adoption

- The Chair updated the participants on the progress of Council discussions. The most recent working party meeting took place on January 28th, during which discussions on the LNE were not reopened. The upcoming working party meetings are scheduled for February 25th and March.
- The Polish Presidency aims to reach a general approach by the end of March and will prioritize this file, with the Trilogue expected to begin in the summer of 2025. A timeline has been shared, outlining key milestones up until the issuance of the EBA guidelines and the implementation of the PSD3.

Action

The Secretariat will continue to closely monitor discussions related to the adoption of the PSR/PSD3.

4) 2025 Action Plan proposal

- In light of the latest national developments and the potential risk of reopening discussions on the LNE topic, participants agreed on the need to reactivate or rebuild a network that can be mobilized during the PSR/PSD3 Trilogue.
- Meetings should be organized by mid-March with a select group of representatives from Member States' Permanent Representations in Brussels, the European Commission, and the European Parliament.
- A new position paper should be issued to reaffirm FCE's previous stance on the PSD2 revision, while also providing an explanation of how fleet cards work and an assessment of how PSD2 is currently implemented across various Member States.

New Action

The Secretariat will prepare:

- a mapping of relevant individuals to be engaged,
- a timeline,
- a draft position paper.

All documents will be circulated among working group members for review prior to final approval.

5) Working Group Assessment

- The Secretariat informed that one of its priorities set by the Board is to review working group priorities and streamline activities for greater efficiency and member engagement.
- Members will be consulted for input, either through bilateral meetings or survey.
